THE CONTEST SPONSOR:

The \$20,000 ANNIVERSARY GIVEAWAY ("the Contest") is conducted by N. Tepperman Ltd. ("Tepperman's"), the Contest Sponsor and Administrator.

ELIGIBILITY:

The Contest is open to residents of the province of Ontario, Canada who are the age of majority and who are residing in Ontario, Canada at the time of contest entry and the Grand Prize draw. For greater clarity, any person residing outside of Ontario, Canada during the contest entry and draw periods is not eligible to enter.

You are not eligible if, during the Entry Period, you are an employee or partner of Tepperman's or a member of the immediate family (defined as mother, father, brother, sisters, sons, daughters and husband or wife, regardless of where they reside) or household member of any of the above persons, their respective affiliates, agents, licensors, associates, representatives and advertising agencies. If an individual meets the aforementioned requirements then they will be considered an "Eligible Entrant" for the purposes of this Contest.

CONTEST DATES:

Contest Begins: September 11, 2020

Contest Ends: November 19, 2020

Random Draw Date: November 24, 2020

THE DRAW DETAILS:

There will be twenty (20) random Prize Draws. The Prize Draws will take place on the dates and times in the above Schedule, at the Management Office of Tepperman's at 2595 Ouellette Avenue, Windsor, Ontario N8X 4V8. The Entries chosen in each Prize Draw will become the "Selected Entrants" and must meet the conditions outlined below in order to be declared the "Winner".

PRIZE DETAILS:

There will be a total of twenty (20) Prizes awarded. Each Prize consists of a \$1000 Tepperman's Gift Card, redeemable for a merchandise purchase at any Tepperman's store location. The Selected Entrant agrees to accept the Prize as described in these rules. The Prize is not transferable to another individual, is not redeemable in whole or in part for cash or credit, and no substitutions will be permitted.

CONTACTING THE SELECTED ENTRANT:

The "Selected Entrant" will be notified by an email from a Tepperman's representative within approximately two (2) business days after each Prize Draw. If for any reason the Selected Entrant cannot be reached after two (2) attempts that are two (2) days apart, and does not respond by the deadline in the email, his/her Entry will be declared null and void, and the prize will be forfeited. The Contest Sponsor reserves the right to select at random another eligible Entry.

The Contest Sponsor will not be held responsible for the loss of a Prize due to changes in email addresses, or any other circumstances leading to an invalid, erroneous or incomplete email address.

TO BE DECLARED A WINNER:

8. To be declared the "Winner", the Selected Entrant must, in addition to meeting the Contest eligibility criteria and otherwise complying with the Official Contest Rules, first: Be reached by email by the Contest Sponsor's representatives within the two (2) business days immediately following the Draw of the Entry (2 contact attempts will be made, 2 business days apart);

Complete and sign the Sponsor's Declaration and Release Form and return it to the Sponsor or its representatives by the deadline given on the Form and return it to Tepperman's representative at the store where the gift card is picked up;

Should the Prize be unclaimed after two (2) weeks, or should the Selected Entrant be unwilling, unable or ineligible to win the Prize as set out in these Official Rules, the Prize will be forfeited and Tepperman's reserves the right to draw another Entry ("Alternate Entrant"). The Alternate Entrant will be contacted following the same method as set out above.

AWARDING THE PRIZE:

Upon the completion and signing of the Declaration and Release Form, the Prize of a \$1000 Tepperman's Gift Card can be claimed in the Tepperman's store location of the Winner's choosing. Personal identification will be requested prior to awarding the prize.

GENERAL TERMS AND CONDITIONS

PARTICIPATION:

Participation in this Contest constitutes an agreement by each Entrant to comply with these Official Rules.

ODDS OF WINNING:

The odds of winning a Prize depends upon the number of eligible Entries received in accordance with these Official Rules.

VERIFICATION OF ENTRIES:

The validity of any Contest entry is subject to verification by the Sponsor. The Sponsor reserves the right, in its sole and absolute discretion, to require proof of identity and/or eligibility (in a form acceptable to the Sponsor – including, without limitation, government issued photo identification) for the purposes of administering this Contest in accordance with these Rules. Failure to provide such proof to the complete satisfaction of the Sponsor within the timeline specified by the Sponsor may result in disqualification in the sole and absolute discretion of the Sponsor.

In the event of a dispute regarding the identity of an entrant, the entry will be deemed to have been submitted by the authorized holder of the email address at the time of entry. For these purposes, the "authorized holder" is the natural person who is assigned to the submitted email address by an Internet access or online service provider, or other organization responsible for assigning email addresses for the domain associated with the submitted email address on the Entry Form.

Any incomplete, duplicate or fraudulent entries will be rejected. Any entrant or other individual who enters or attempts to enter the Contest in a manner which is contrary to
