



OFFICIAL CONTEST RULES TEPPERMAN'S CHAD SOFA GIVEAWAY

THE CONTEST SPONSOR:

TEPPERMAN'S CHAD SOFA GIVEAWAY (the "Contest") is sponsored by N. Tepperman Ltd. ("Sponsor"), 2595 Ouellette Avenue, Windsor, Ontario, N8X 4V8.

ELIGIBILITY:

This Contest is open to residents of the province of Ontario who are the age of majority at time of entry and who are residing in one of the Sponsor's regular delivery zones as outlined in Appendix A at the time of Contest entry and the applicable prize draw. For greater clarity, any person residing outside of the Sponsor's regular delivery zones during the Contest entry and draw periods is not eligible to enter.

CONTEST DATES:

PRIZE DRAWS:

There will be six (6) random prize draws. The prize draws will take place on the date and time above at the Sponsor's Management Office at 2595 Ouellette Avenue, Windsor, Ontario N8X 4V8. The entries chosen in each prize draw will become the "Selected Entrants" and must comply with all these Official Contest Rules to be declared a winner.

CONTEST PRIZES:

There are a total of six (6) prizes available to be won. The Selected Entrants agree to accept the prizes as awarded. The prizes are not transferable to another individual, are not redeemable in whole or in part for cash or credit, and no substitutions will be permitted. Prizes may not be exactly as shown. The Sponsor reserves the right to substitute a prize in whole or in part in the event that all or any of the components of a prize are unavailable.

CONTACTING SELECTED ENTRANTS:

The Selected Entrants will be notified by e-mail and/or phone call from a representative of the Sponsor within two (2) business days after the Draw Date. If for any reason a Selected Entrant cannot be reached after two (2) attempts and does not respond by the deadline in the e-mail/message, his/her entry will be declared null and void, and the prize will be forfeited. The Sponsor reserves the right to select at random another eligible entry.

The Sponsor will not be held responsible for the loss of a prize due to changes in e-mail addresses, or any other circumstances leading to an invalid, erroneous or incomplete e-mail address.

TO BE DECLARED A WINNER:
